QUESTIONS FOR CITY:

1. 385021000: north part of parcel has been built on; this is on an alley. Has the city ever abandoned the alley? The taxable area would then increase
2. 385056000: 6521 School St. storage unit on 2nd Ave. right of way or was street ever abandoned? (sometime after 2013). If abandoned, who owns it?
3. 380037000: Schaefer Park; Beacon maps show that it is not owned by the City of Finlayson. The front portion of the driveway is owned by deceased Joseph & Mary Drahosh and the HF school district owns the park itself. This raises questions of liability as well as taxation.
4. 385084000: An awareness item for the city that Finlayson owns the property owners driveway and most of the front yard. Before the new sewer lines come to this area, the street may need to be realigned to fit the cul-de-sac or make a hammerhead at the end of the street.
